## A lasting gift

Each year we make hundreds of grants to small charities and voluntary groups in Hampshire and the Isle of Wight, but there are always many worthwhile applications that we must turn down through lack of funds.

# Your generosity could help us fund projects like these:

- a lunch club to combat loneliness and isolation amongst older people
- a programme of social activities for people with learning difficulties
- a community bus service benefiting pensioners and other local people
- to support young people and those with disabilities

The Foundation offers the flexibility for you to decide whether to leave a gift to support a particular cause or geographic area, or allow the Fund to allocate your gift according to the most current pressing needs. In addition, a 'Named Gift' will ensure your name (or a friend's or relative's) will live on.

A gift in your Will, of whatever size, will enable us to help more charities and voluntary groups to do what they do well—to tackle local problems and care for local people in need. With a gift in your Will to the Hampshire Community Fund you can be confident that gift will continue to support your local community for many years to come.

## Leaving a gift

The Foundation welcomes legacies of all kinds including land, property, stocks and shares.

The types of gifts in your Will include:

**Pecuniary** – where a specified sum of money is given.

**Specific** – where a specified item, such as shares or property, is given.

**Residuary** – where the Fund receives all or, more usually, part of the Estate, after any other legacies have been paid.

**Reversionary** – where we receive the residue of the Estate after the death of a surviving spouse.

### Establishing your own Fund

You can decide to have a Fund named after you, your family or in a way that reflects something important to you. Alternatively, you can leave a gift to the Hampshire Community Fund. You can specify exactly how you would like your gift to be used or you can leave it to us to decide how it is spent.

## Lifetime giving

Increasingly, people are coming to us to set up a family or other Fund in their own lifetime, into which a gift in a Will can eventually be placed. This approach enables you to see the impact of your giving today. It also provides the opportunity to encourage other family members to become involved in your fund.
