Health Profile 2015

Health in summary

The health of people in New Forest is generally better than the England average. Deprivation is lower than average, however about 12.2% (3,400) children live in poverty. Life expectancy for both men and women is higher than the England average.

Living longer

Life expectancy is 5.1 years lower for men and 3.8 years lower for women in the most deprived areas of New Forest than in the least deprived areas.

Child health

In Year 6, 14.9% (229) of children are classified as obese, better than the average for England. The rate of alcohol-specific hospital stays among those under 18 was 62.8*, worse than the average for England. This represents 20 stays per year. Levels of breastfeeding and smoking at time of delivery are better than the England average.

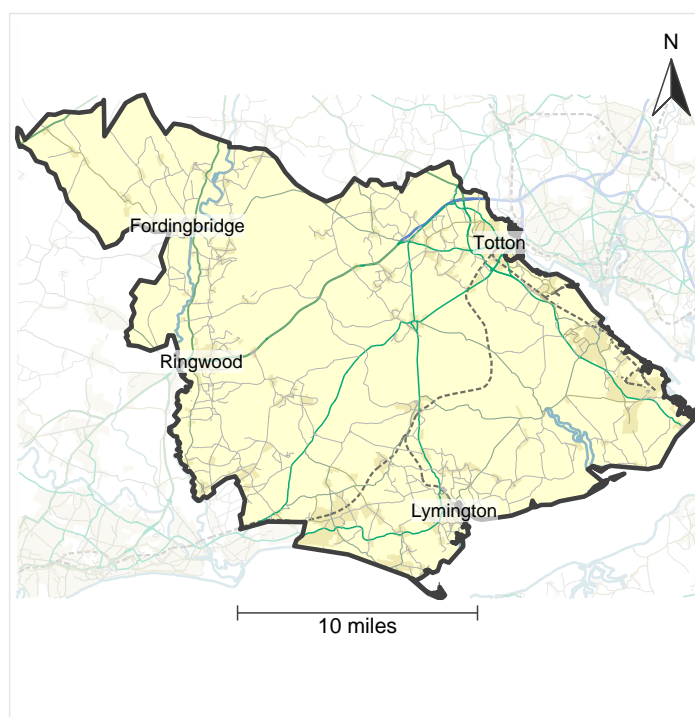
Adult health

In 2012, 21.6% of adults are classified as obese. The rate of alcohol related harm hospital stays was 540*, better than the average for England. This represents 1,022 stays per year. The rate of self-harm hospital stays was 205.7*. This represents 326 stays per year. The rate of smoking related deaths was 203*, better than the average for England. This represents 299 deaths per year. Estimated levels of adult excess weight are worse than the England average. Estimated levels of adult physical activity are better than the England average. The rate of people killed and seriously injured on roads is worse than average. Rates of sexually transmitted infections and TB are better than average. The rate of new cases of malignant melanoma is worse than average. Rates of statutory homelessness, violent crime, long term unemployment, drug misuse, early deaths from cardiovascular diseases and early deaths from cancer are better than average.

Local priorities

Priorities in New Forest include older people, alcohol, healthy weights, self-harm, road safety, and reducing health inequalities. For more information see www.newforest.gov.uk or www.hants.gov.uk

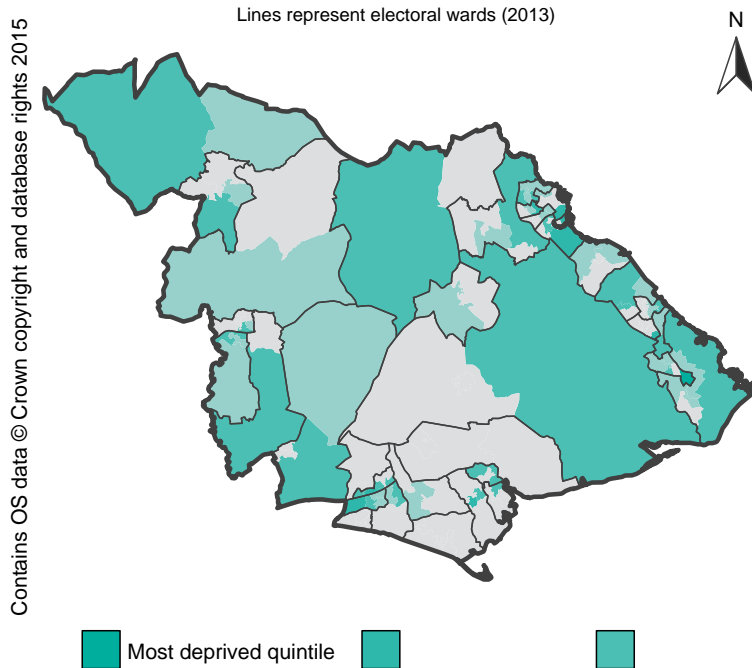

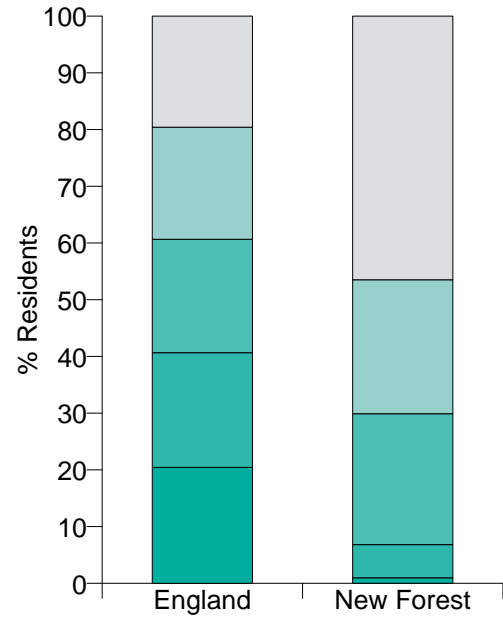

The map shows differences in deprivation in this area based on national comparisons, using quintiles (fifths) of the Index of Multiple Deprivation 2010, shown by lower super output area. The darkest coloured areas are some of the most deprived neighbourhoods in England.



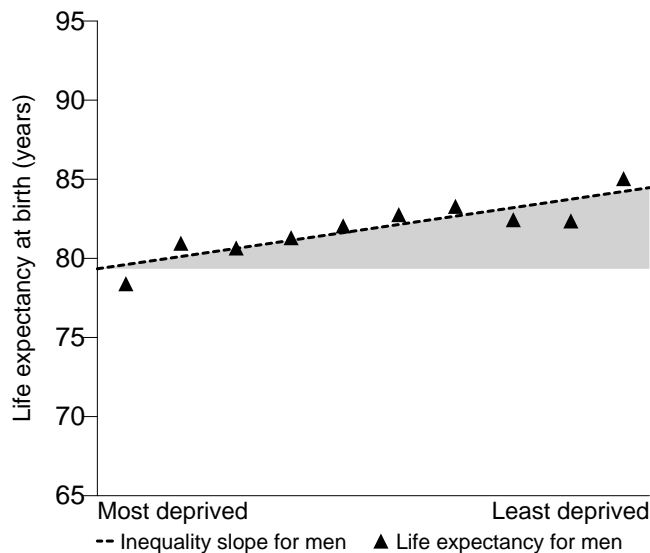
This chart shows the percentage of the population who live in areas at each level of deprivation.



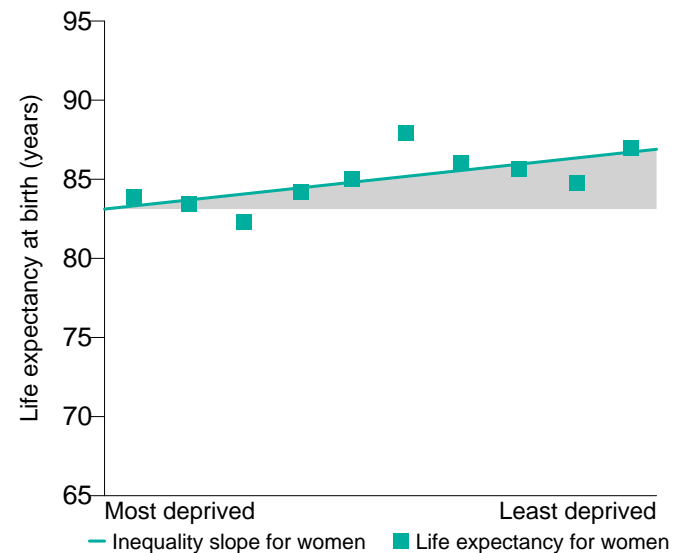
Life expectancy: inequalities in this local authority

The charts below show life expectancy for men and women in this local authority for 2011-2013. Each chart is divided into deciles (tenths) by deprivation, from the most deprived decile on the left of the chart to the least deprived decile on the right. The steepness of the slope represents the inequality in life expectancy that is related to deprivation in this local area. If there were no inequality in life expectancy as a result of deprivation, the line would be horizontal.

Life expectancy gap for men: 5.1 years



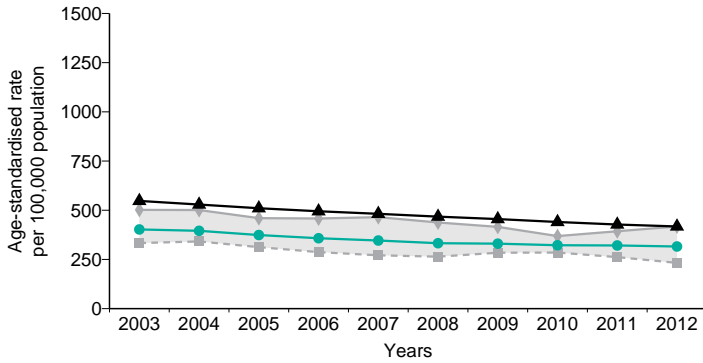
Life expectancy gap for women: 3.8 years



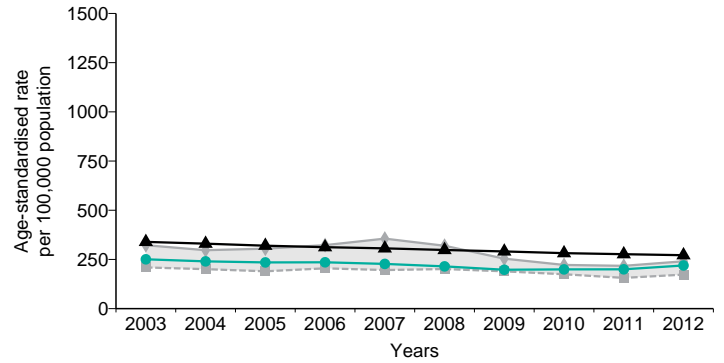
Health inequalities: changes over time

These charts provide a comparison of the changes in early death rates (in people under 75) between this area and all of England. Early deaths from all causes also show the differences between the most and least deprived quintile in this area. (Data points are the midpoints of 3 year averages of annual rates, for example 2005 represents the period 2004 to 2006).

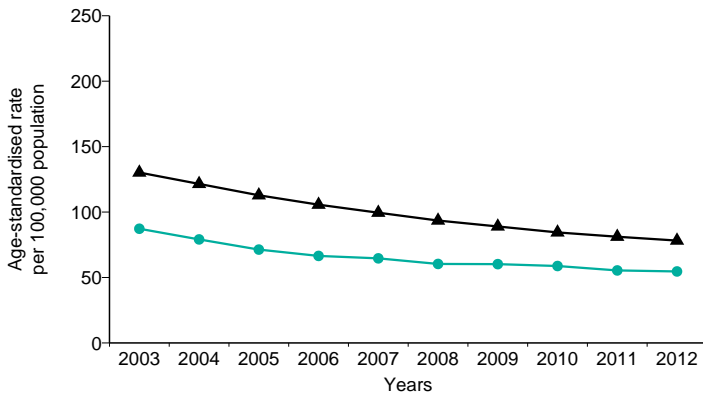
Early deaths from all causes:
MEN



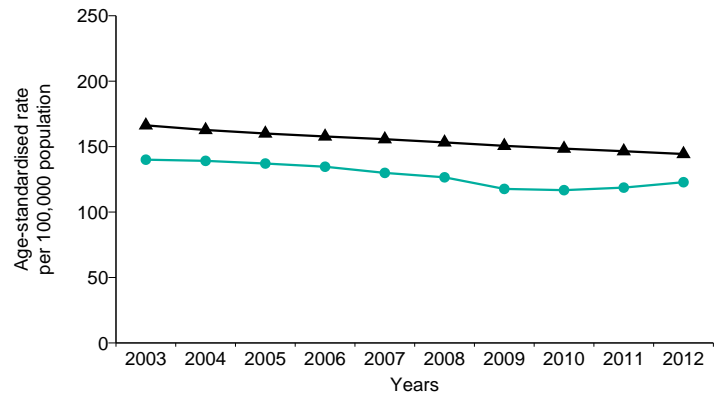
Early deaths from all causes:

Early deaths from heart disease and stroke



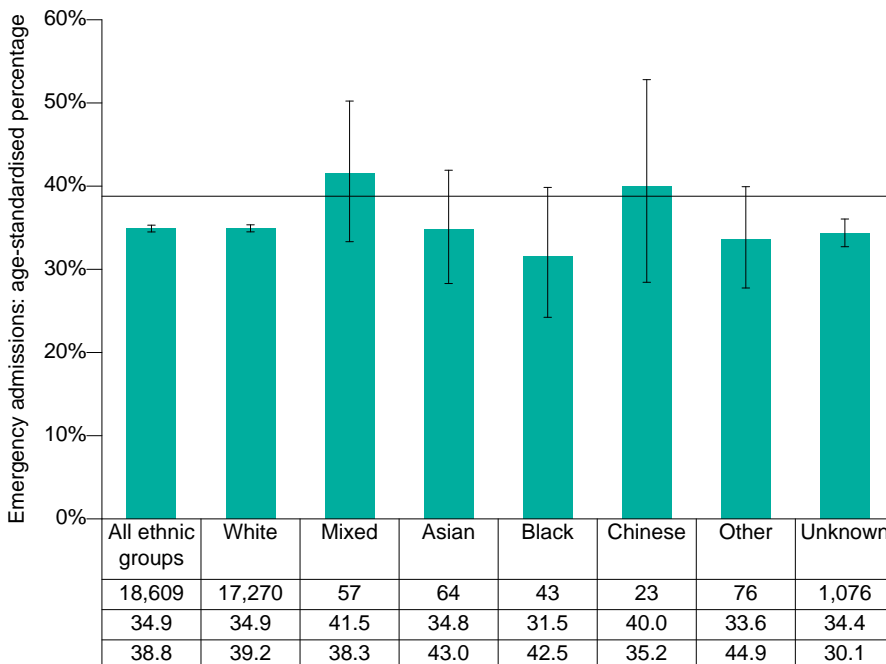
Early deaths from cancer

Health inequalities: ethnicity

Percentage of hospital admissions that were emergencies, by ethnic group, 2013



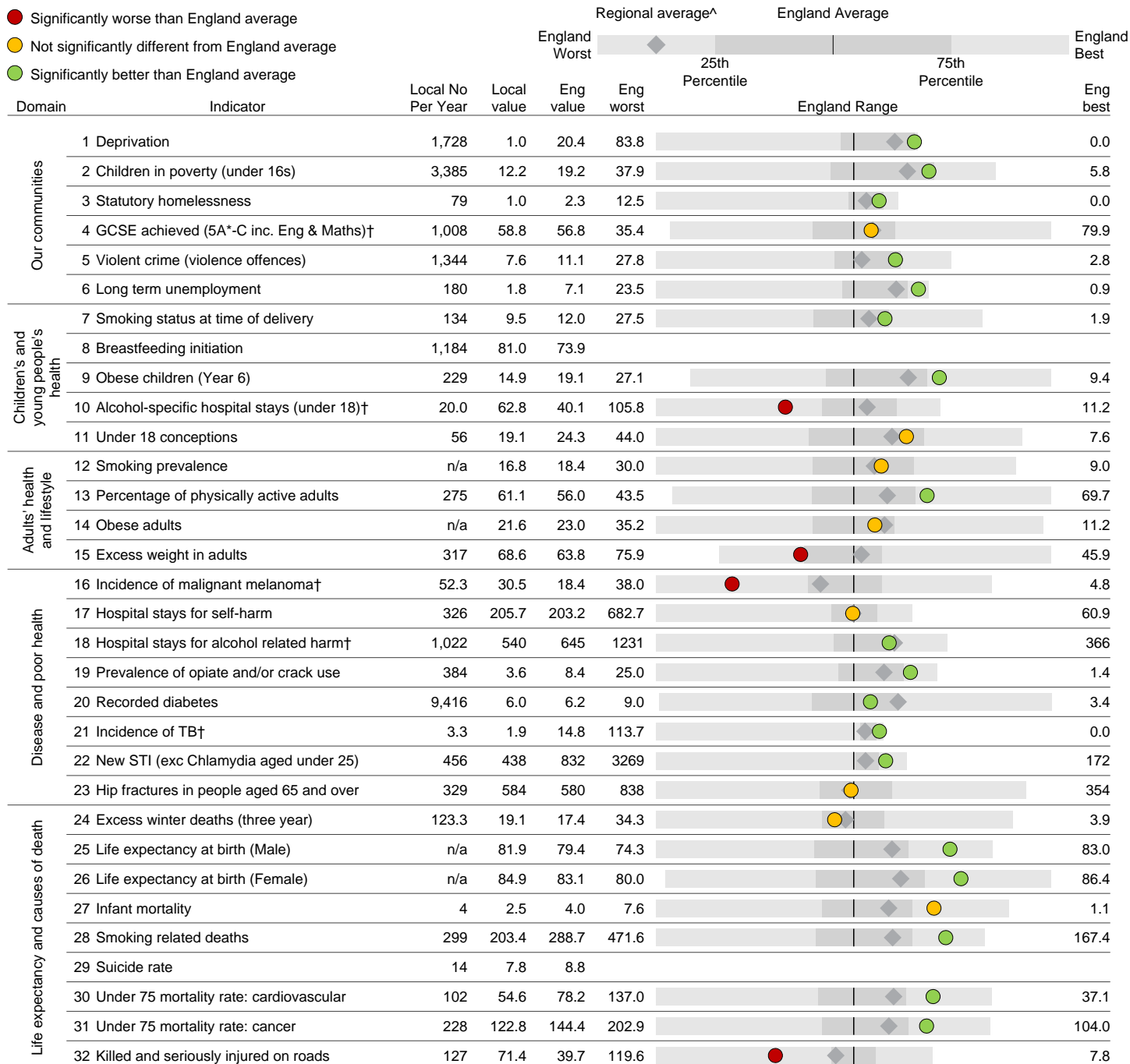
This chart shows the percentage of hospital admissions for each ethnic group that were emergencies, rather than planned. A higher percentage of emergency admissions may be caused by higher levels of urgent need for hospital services or lower use of services in the community. Comparing percentages for each ethnic group may help identify inequalities.

Health summary for New Forest

The chart below shows how the health of people in this area compares with the rest of England. This area's result for each indicator is shown as a circle. The average rate for England is shown by the black line, which is always at the centre of the chart. The range of results for all local areas in England is shown as a grey bar. A red circle means that this area is significantly worse than England for that indicator; however, a green circle may still indicate an important public health problem.
